## Who is “Mighty Madison”?

Madison Faith Milio was diagnosed with an inoperable tumor in her brain stem on April 1, 2019. Since her diagnosis, she has gone through radiation therapy, infusions of chemotherapy and Avastin, and also took part in a T-cell trial in Washington, D.C. Madison continues to fight her battle with her family by her side. Her nickname of “Mighty Madison” signifies the strength and determination she shows each and every day. Mighty Madison is an inspiration to us all.

## Things to Know About DIPG

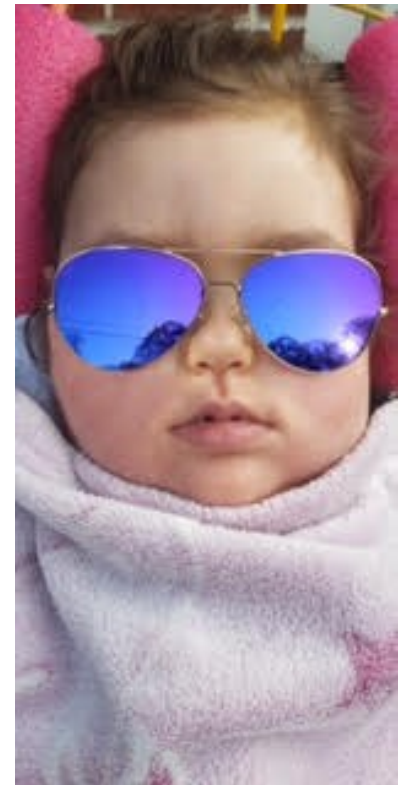
Diffuse intrinsic pontine glioma, or DIPG, is an extremely rare pediatric brain tumor. It is an aggressive form of brain cancer and is the leading cause of brain tumor deaths in children.

DIPG typically strikes between the ages of 5 and 11, infiltrates the brain stem, and has a 0% survival rate.

Treatment for DIPG has gone unchanged for nearly 40 years. Astronaut Neil Armstrong lost his young daughter, Karen, to DIPG in 1962. Protocols for treatment and life expectancy have not changed much since that time.

The chances of surviving 2 years following a diagnosis are about 10% while the chances of surviving beyond 5 years is about 2%, which happens to be up by 1% since 2018. The median survival time is 9 months from diagnosis.

Funding for research is lacking. In fact, less than 4% of the federal government’s research investments go toward childhood cancer, and even less for childhood brain cancer.

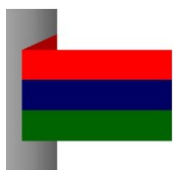
